You understand that you are providing your information to Maui Jim, Inc. The information you provide will only be used for the purpose of contacting winners and awarding prizes, unless you have opted to receive communication from the Sponsor. Any questions, comments or complaints regarding the Sweepstakes must be directed to the Sponsor.

(1) Description of Sweepstakes – Maui Jim, Inc. (the "**Sponsor**") is offering the "Maui Jim Maui Invitational Tournament Sweepstakes" (the "**Promotion**") and will award one (1) Grand Prize via a random selection from all eligible entrants. The Promotion begins August 10, 2019 at 12:00:01 AM Central Time ("CT") and ends at 11:59:59 PM CT on September 10, 2019 ("**Promotion Period**").

By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. By participating in the Promotion, participants agree to release, discharge and hold harmless Promotion Entities (defined below) from any and all damages whether direct or indirect, which may be due to or arise out of participation in the Promotion or any portion thereof, or the acceptance, use/misuse or possession of prizes.

(2) Eligibility - The Promotion is open to legal residents of the fifty (50) United States and the District of Columbia (excluding Puerto Rico and all other U.S. territories and possessions and overseas military installations) who are eighteen (18) years of age and/or have reached the age of majority in their state of residence at time of entry. (4) Grand Prize – On or about September 12, 2019, One (1) winner will be randomly selected to receive one (1) trip for two (2) people (winner and one (1) guest) to the Maui Jim Maui Invitational Tournament, November 25-27, 2019 in Maui, HI ("**Grand Prize Trip**").
